



## Section 3 – External Auditor Report and Certificate 2020/21

In respect of **UPPER MEDWAY INTERNAL DRAINAGE BOARD – DB0114**

### 1 Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2021; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

### 2 External auditor report 2020/21

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The smaller authority has not approved the AGAR in accordance with the Accounts and Audit Regulations 2015, since the approval took place at the Finance Committee meeting and the minutes of the following Board meeting indicate that the AGAR was received, rather than approved. In future years, the Board must ensure that approval of the AGAR is given by the full Board.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report, the internal auditor has drawn attention to significant weaknesses in relation to the budgetary process, payments to staff and the publication requirements of the Accounts and Audit Regulations 2015. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
